

1. Modify the Windows System "PATH" environment variable from using 'STE_libs' to using 'ste-shared-libraries'

After: <Your TruckMate Install Location>\STE\ste-shared-libraries\

ie. To change your SYSTEM path variable:

- Go to Start -> Run or press the Windows+R key
- In the Open field type: sysdm.cpl and click OK
- Select the Advanced tab
- Click the Environment Variables ... button
- In the System variables section, select the Path variable and click Edit...
- Replace any instance of C:\Program Files (x86)\TruckMate 20XX\STE\STE_libs\ with C:\Program Files (x86)\TruckMate 20XX\STE\ste-shared-libraries\
- Click OK
- Click OK
- Click OK

2. Physically replace the existing STE sub-folder with the updated STE files included in the Truckmate patch release.

The motivation for this came from the setup for the recently added Oregon PFML & Colorado FAMLI (family leave) plans. The employee portion for these are subject to a maximum (wage base) for the year. Since Truckmate implemented them on the local tax deductions screen, there needed to be a way to set that maximum. For example: Oregon PFML contribution rate is 1% of wages (0.6% is employee portion) to a maximum of \$132,900 in wages (so you would put 132,900 in the maximum field)
